AGE limit

- i. Pakistani National 18 to 25 years + 05 (Five years) General age relaxation in upper age limit on **27.12.2021.**
- ii. In case of Ex.Servicemen, the upper age limit is relax-able to the extent of service rendered by him in the Armed Forces or 15 years in addition to item No.1 above, whichever is less.
- iii. The age of candidates belonging to the scheduled Castes, Buddhist Community, Sindh Rural Areas is relaxed for 03 years in addition to item No.1,above.
- iv. Age limit is relaxable upto 3 years for the Candidates belonging to Sindh (Rural).
- v. Government servants and contract employees who have completed 2 years continuous Government service on the closing date of receipt of application age limit is relaxable 10 years in addition to item No.(i),above.
- vi. Only those applicants belonging to District/Districts falling under territorial jurisdiction of Karachi Division are eligible to apply.
- vii. Only male candidates are eligible.
- viii. The age of Sons of deceased Civil Servant who has died during service is relaxed by 05 years in addition to item No.1,above.

INSTRUCTIONS/TERMS AND CONDITIONS OF THE RECRUITMENT.

1. Only those candidates who fulfill all the terms & conditions and found eligible, will be called for selection. Only those candidates will be called afterward for interview who will qualify the test.
2. In case of Children of Railway employees, the father /mother of the candidate has to submit an affidavit that no one of his children has been appointed against Railway employees quota previously.
3. The selected candidates will be required to pass prescribed Medical examination from Pakistan Railways Hospital only.
4. Candidates who have at any time been convicted of offences involving moral turpitude who have been dismissed by the Central or any provincial Government of Pakistan will be considered ineligible for recruitment.
5. Candidate who has married or intends to marry a person who is not National of Pakistan, shall not be eligible for appointment to any service or post under the Government of Pakistan.
6. Government including Railway Servants should submit applications through their respective department /proper channel.
7. No previous application, if any, will be entertained. Candidates may apply afresh.
8. No relaxation in educational qualification and in the Medical fitness test.
9. The regional quota where applicable will be followed.
10. No TA/ DA or other expenses will be paid to candidates called for Physical / interview / Medical examination.
11. Disabled persons and women are not eligible.
12. Using internal/external influence for recruitment will render a candidate ineligible and disqualified for any employment in Pakistan Railways.
13. Number of posts can be reduced/increased due to administrative reasons.
14. The competent authority has the right to reject any application/ all applications without assigning any reason under the rules.
