Applications are invited from retired ASMs/SMs for appointment as ASM Gr-I (BS-10) (on contract basis for a period of "One" year) in Pakistan Railways, Multan Division:-

Terms and conditions:-

1. The candidates who have been compulsorily retired, removed, dismissed from service or retired on Medical grounds will not be eligible for the said post.
2. Tenure (Contract appointment) will be upto 62 years (further extendable subject to approval by Ministry of Railways).
3. Only eligible / shortlisted candidates will be called for interview by the selection committee.
4. Selected candidates will be required to pass Medical Examination from Pakistan Railways Hospital, Multan.
5. The candidates having domicile of Multan Division will be given preference.
6. The Candidates who are aware of CBI System and worked on it shall be given preference.
7. Selected candidates will have to undergo mandatory course (R-12) before their engagement as ASM Gr-I/BS-10 from Pakistan Railways Academy Walton, Lahore.
8. Selected candidates will be paid pay of BS-10 and other allowances admissible under contract appointment as per policy/directives issued by Headquarters Office, Lahore. However, they will not be entitled for gratuity and pension.
9. The selected candidates will be bound to work at any station on Multan Division.
10. The competent authority has the right to reject any application for contract appointment without assigning any reason.
11. The administration has the right to terminate contract appointment of any selected candidate, without assigning any reasons at any stage.
12. No TA/DA will be paid to the candidates who will be called for Interview, Medical Examination or other formalities.
13. Above number of posts can be changed without assigning any reason.

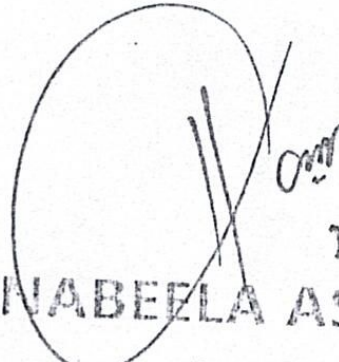
