

**ANNEXURE-"A"****CRITERIA FOR EVALUATION OF TECHNICAL PROPOSAL****1. General**

The technical proposal of the Bidders shall be evaluated for qualification of bidders for the subject Bid based on the criteria regarding Eligibility, Work Experience, Equipment Capabilities and Financial Soundness as follows;

**2. Weightage/Marks**

The weightage/distribution of the marks shall be as given below:

- c) Litigation history / Affidavit on Legal Stamp paper in original to the fact that no litigation hinders the bidder to participate in this tender.
- d) Affidavit on legal stamp paper declaring that the firm has never been black listed.
- e) Affidavit on legal stamp paper declaring that the firm has supplied the material within due time for last two years in CSF/Directorate. If the firm has already working in CSF/Directorate.
- f) Bid Security as mentioned in tender documents from Scheduled Bank in Pakistan in favor of MD/CSF or FA&CAO/M&S, Pakistan Railways, Headquarters office Lahore as per BDS (Clause-18).
- g) The bidder must allow that the purchaser shall have the right of stage inspection of manufacturing facilities. The signatures of bidders on all pages of bidding documents will be considered their permission.
